DIRECTIONS FOR USE

Agitate well before use. Always use diluted and do not exceed recommended rate per hectare.

APPLICATION RATES

Broadacre: Use at least 80L /ha of water.

CROP	RATE/HA	APPLICATION RATES AND TIMING
Cereals	2-4L/ha	Apply at leaf stage
Legumes	2-4L/ha	Apply when sufficient foliage is present. Spray as required.
Pasture	2-5L/ha	Apply when sufficient foliage is present. Spray as required.
Lucerne	3-5L/ha	Apply when sufficient foliage is present. Spray as required.
Seeding in furrow	2-4L/ha	Apply at planting

Frequencies and rates are guidelines only.

Store out of direct sunlight and mix well prior to use.

Foliar fertilisers work best when applied in cool dry conditions. Do not apply as a foliar when temperatures exceed 25 degrees Celsius. Do not apply as a foliar fertiliser if crop is more than 20% flowering.

COMPATIBILITY

Smart Select Organic Chelate ZC + Moly is compatible with most agricultural chemicals and fertilisers. Do not mix with Amine herbicides and Calcium containing products. When mixing, always test for compatibility with a small quantity first and only mix enough for one application. Do not store the mixed product. Do not mix with inoculants and alkaline products.

CROP SAFETY

Always test the rate to be applied on a small trial area before using on large areas. Always jar test before mixing with other products to check compatibility. If fallout occurs do not continue. Always ensure spraying conditions are suitable i.e. humidity, wind speed, temperature, prior to application.
